GDPR Privacy Notice

1. Introduction

- 1.1. Wiltshire Working Gundog Society is committed to protecting your personal information and respecting your privacy.
- 1.2. This Privacy Notice sets out the basis on which any personal data that we collect from or about you, or that you provide to us, will be processed by us.
- 1.3. For the purpose of the General Data Protection Regulation [the GDPR], the data controller is Wiltshire Working Gundog Society.
- 1.4. We may update this Privacy Notice from time to time. Please check back regularly to see any updates or changes to this Notice.

3. Data Protection Principles

We will comply with data protection law. This says that the personal information we hold about you must be:

1. Used lawfully, fairly and in a transparent way.
2. Collected only for valid purposes that we have clearly explained to you and not used in any way that is incompatible with those purposes.
3. Relevant to the purposes we have told you about and limited only to those purposes.
4. Accurate and kept up to date.
5. Kept only as long as necessary for the purposes we have told you about.
6. Kept securely.

Particulars of processing

- 3.1. We process personal data about members, judges, competitors, stewards and auxiliary assistants to our events. The categories of person about whom we process personal data are described in more detail in the Annex to this Privacy Notice.

4. Your rights as a data subject

- 4.1. The General Data Protection Regulation provides the following rights (subject to some exemptions):
 - 4.1.1. The right to request access to the personal data that we hold about you;
 - 4.1.2. The right to request rectification of the personal data that we hold about you;
 - 4.1.3. The right to request erasure of the personal data that we hold about you;
 - 4.1.4. The right to request restriction of processing about you;
 - 4.1.5. The right to object to processing; and
 - 4.1.6. The right to data portability.

If you wish to raise a complaint on how we have handled your personal data, you can contact our Secretary at the details above.

If you are not satisfied with our response or believe we are processing your personal data not in accordance with the law you can complain to the Information Commissioner's Office (ICO) full contact details for which can be found at <https://ico.org.uk/global/contact-us/>

5. How we will use information about you

We will only use your personal information when the law allows us to. Most commonly, we will use your personal information in the following circumstances:

1. Where we need to perform the contract we have entered into with you.
 2. Where we need to comply with a legal obligation.
 3. Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.
- We may also use your personal information in the following situations, which are likely to be rare:
1. Where we need to protect your interests (or someone else's interests).
 2. Where it is needed in the public interest [or for official purposes].

- 6.1 We will generally process your personal data for contractual necessity in providing membership services and events. We may also use personal information for additional relevant and related purposes where you might reasonably expect us to do so, where the benefits of doing so are not outweighed by your own interests or fundamental rights or freedoms. This may include:
- 6.1.1. To maintain our records and other administrative purposes, including updating your details and preferences:
 - 6.1.2. To assist with queries, complaints and dispute resolution;
 - 6.1.3. For communications related to membership and invitations to participate in canine market research or canine health studies:
 - 6.1.4. To assist with upholding our club constitution and taking action in cases where there may be a breach of the Club rules or Codes of Ethics.
- 6.2 We will ask for your direct consent IF we intend to use your personal data for marketing purposes. Where our processing of personal data is based on your having given consent, you have the right as a data subject to withdraw that consent at any time. If you wish to invoke this right, please notify the Secretary using the contact details set out in Section 2 above.
- 6.3 You have the right to lodge a complaint with a supervisory authority. In the United Kingdom, the supervisory authority is the Office of the Information Commissioner, full contact details for which can be found at <https://ico.org.uk/global/contact-us/>

6. Recipients of Data

- 6.1. We may use service providers to help us provide you with our services. Personal data may be transferred to such service provider, who act for or on our behalf, for further processing in accordance with the purpose(s) for which the data was originally collected or may otherwise be lawfully processed.
- 6.2. Such third parties have contracted with us as data processors under the requirements in the GDPR. They are contractually bound to only use personal data for the agreed purpose(s). Relevant persons

working for these third parties will have access to your personal data under the terms of the data processor contract, but only to the extent necessary to perform their services for us.

- 6.3. These data processors agree to implement reasonable contractual and technical protections, to keep your data confidential, not sell your personal data to third parties and to not disclose your personal data to third parties except as may be required by law, as permitted by us or as stated in this Privacy Policy.
- 6.4. In appropriate circumstances we may disclose data to authorised bodies as required by law.

7. Visitors to Wiltshire Working Gundog Society websites – Cookie Policy

7.1. We use cookies to gather statistical information to monitor how people use our websites and help us to understand what users find interesting and useful on our websites. We do not use this code to collect any personally identifiable information. Our first party cookies set directly by our website collect data on:

- 6.1.1 Number of unique visitors to the websites
- 6.1.2 Number and pages viewed

7.2. We collect these cookies under Legitimate Interests in order to provide you with our online services and to analyse visitor behaviour on our websites.

7.3. Cookie information is held on your browser and you can amend your browser settings at any time. However, please be aware that blocking or deleting all cookies will affect the functionality and usability of our websites.

7.4. Third party cookies: With our web design provider, Damteq Solutions Ltd, we use Google Analytics to understand how the site is being used in order to improve the user experience. We also process personal data for the Society's legitimate interests as we have outlined in the main Privacy Notice (paragraph 6.1). Please be assured that we will always take account of your personal data rights in doing so.

Where do we obtain your personal data from?

Most of the above personal data is received direct from you (the data subject). However, information may be received from third parties such as FTMS (Field Trial Management System), Fosse Data Systems or other individuals in provision or assistance of society business.

How long do we hold your personal data for?

Personal data will be retained in accordance with statutory requirements, Kennel Club requirements and recommendations and the Society's retention policy which is available on request from our Secretary.

Are you obliged to provide us with your personal data?

You are not obliged to provide the personal data in question. However, if you do not provide the personal data, we will be unable to perform any contract we have with you for the provision of membership services, judging appointments or event services.

Recipients of your personal data

We disclose data to the following outsourced data processors, in line with section 7 of our main Privacy Policy, for the purposes of performing any contract we have with you for the provision of membership services, judging appointments or event services:

FTMS (Field Trial Management System)	Processing your field trial and competition entries Membership database services Membership email communications services

Ralph Allen Press	Processing electronic bulk postal addressing on printed mailings of communications to members
Damteq Solutions Ltd	Processing and publication of notices, e.g. competition results, on the Society's websites

We require the end party to take appropriate safeguarding measures and third parties to respect the security of your data and to treat it in accordance with the law.

We may transfer your personal information outside the EU; for example, in using larger service providers (such as Amazon, Google etc.) who are likely to use model clauses or ensure appropriate safeguards are in place for common applications.

If we do, you can expect a similar degree of protection in respect of your personal information.

Kennel Club records

The Kennel Club will hold the personal data of officers of the Society as a part of the implementation of Kennel Club Rules and Regulations.

We provide the Kennel Club with details of the Wiltshire Working Gundog Society officers and field trial competitors at our events in order to meet requirements in the Kennel Club Rules and Regulations.

We provide competition entrants' data to our third-party printing company for inclusion in the event running card.

Do we use your data for any automated decision-making?

No personal data is processed for automated decision-making

Any financial data arising from a transactional process will be held securely by the Wiltshire Working Gundog Society in accordance and compliance with all statutory and HMRC requirements.
